**Sub: Bill form for drawl of claim of Interest as per judgement of Hon'ble Court**

In pursuance of Notification No.965-F(Y) dated-18.02.2018 T.R Forms were introduced for drawal through digitized format through e-Billing module of IFMS. Thereafter some more T.R Forms were introduced for drawal through digitized format.

Recently T.R Form No.73 was introduced vide Notification No.2646-F(Y) dated-03.05.2019 for drawal of various types of claims in the form of allowances etc which are not drawn through regular Pay Bill form in T.R Form No.18.

Now references have been received from various DDOs across the state regarding the appropriate T.R Form to be used for drawal of claim for payment of Interest to the employees/ pensioners as per direction of Hon'ble Court. The matter was under active consideration of the Government since some time past.

Accordingly the Governor is pleased to decide that the existing T.R Form No.73 introduced vide No.2646-F(Y) dated-03.05.2019 shall also be used by the DDOs for drawal of claim of interest as per judgement of Hon'ble Court. Changes have already been made in e-Billing module of IFMS. However, this change will not affect the process of payment of Interest to the pensioners as per Hon'ble Courts' order by the Treasury Officer through CTS module of IFMS.


This order shall take effect immediately. Necessary modification in West Bengal Treasury Rules shall be made in due course.
